- details for the grading system;
- an official course outline (or similar) showing the weighting of the unit as a proportion of the total course; and
- a copy of the unit outline detailing the expected course learning outcomes and specified unit learning outcomes.

- Credit transfer applications must be submitted at least 10 business day before each semester start date.
